
Preparation of the first version of the grant agreement data and annexes: 3 weeks after receiving the GAP invitation letter, by **09/12/2025**.

Deadline for the submission of the 'Declaration of Honour' and letters of commitment from implementing partners: 6 weeks from the date of the official information letter, by **30/12/2025**.


Deadline for the conclusion of the grant agreement by both parties (REA and FIBE): 3 months from the official information letter, by **17/02/2026**

The GAP invitation letter does NOT constitute a formal commitment for funding. The final decision on our project (including the grant amount to be awarded) can be taken only later, when the EC finalises grant preparation and the checks that still need to be done (*LEAR appointment, legal entity validation, financial capacity assessment, non-exclusion check, ethics review, security review, etc.*).




